## Treasurer's Report from 01/04/2022 to 31/03/2023

Unfortunately, the Free Church failed to send the club invoices from September to February including the Annual Exhibition in November. This correction has had a big impact on the club finances for this financial year and as a result, the committee have decided to amend the financial report for 2022 to 2023 as follows:

This is a significant loss for the club which mainly results from the reduced entries to Interprint and the lack of Interprint Sponsorship plus increases in rental fees at the Free Church.

The committee have agreed to keep the membership fee as agreed in the AGM at £38 for the 2023-2024 season and are looking to reduce the club costs with a cheaper programme, less expenses and by reviewing sponsorship activities with local companies. Depending on how this goes we may have to ramp up membership fees for the 2024-2025 season to balance the books.

Note that some of the costs are higher this year as we moved from paying expenses in arrears to direct debit like the internet costs.
