

# MINUTES of Committee Meeting held on 26th November, 2025 at 7.30pm, location Nicky Cole's house

All present agreed that finishing the exhibition at 4pm rather than 5pm would be better; very few visitors after 4pm and it would save money. The church is expensive but those present agreed the Free Church the most suitable venue.

A discussion followed on how to save money/increase income so that future exhibitions break even rather than make a loss.

We could do with sponsors - maybe Wex, Camkins, someone in St Ives? Maybe ask in newsletter if any member knows a company who might sponsor. Finding sponsors is difficult and no-one specifically volunteered to try.

The suggestion that opening the exhibition one day only to save money was rejected.

To increase footfall, better signage to exhibition so visitors to downstairs fair don't miss us. Large board pointing upstairs was favoured. Graham will source a board and use it initially for Interprint. Action Graham

Maybe charge members £1 or 50p per print displayed. Ask members at AGM.

Add to AGM Agenda
Mark can move boards for Interprint in his trailer, just need people to lift in and out.

Instead of Michaelmas Fair how about a ghost walk in Cambridge, self guided.

Caroline Clifford from library/museum showing old local photos - Graham will ask if willing to speak. Suggestion for 9th March, maybe a practical outdoors.

Maybe move themed evening to another month, otherwise lots of images required in April. Tom Peck suggested as possible judge.

Nicky will do a mid season update on how buddy scheme is going for next newsletter.

A few speakers still to find, Nicky has in hand. If we choose a more expensive speaker, possibility of advertising to other local clubs.

Golden Lion, not many coming now changed to twice in month.

Graham will remind members at the meeting the week before.

## President's Report, Graham Shirra

- 1. Huge thanks to Debbie Hall and everyone else who helped in one way or another with the Exhibition, including all members who contributed material for display.
- 2. The display in the Next Chance bookshop in Huntingdon happened in October. The shop manager tells me that it generated a fair amount of interest from customers: there may be an opportunity to do a further display sometime.

## Treasurer's Report, Nigel Sandbrook

As I will not be able to attend the next committee meeting, I wanted to submit a brief report on the SIPC Exhibition from a financial perspective. Before covering the figures, I would like to express my strong support for the event and its outcomes.

#### Financial Report

- Income over the two days £221.89 (don't ask!)
- Outgoings
  - Van hire: £50.Hall hire: £504.
- Loss: £332.11

My initial view is that the loss was increased by the extension of opening hours; I understand the event previously concluded at 3 or 4 pm, with this change adding an extra cost of £72 to £144. On a positive note, we saved on transport, thanks to our two wonderful volunteers who generously assisted.

Overall, I believe we should absolutely aim to run the exhibition again. However I recommend we consider ways to achieve at least a break-even outcome next time.

## Interprint Competition Secretary's Report, Graham Shirra

- 1. We currently have 18 entries (17 clubs who have actually paid, plus ourselves). That compares with 21 last year.
- 2. I am still following up with some clubs (entry doesn't close until 14 December) and there will be something in the next EAF Bulletin due out soon, but we seem unlikely to see over 20 entries. However, 18 is still a viable competition.
- 3. 3 regular participant clubs (Biggleswade, Ipswich and Royston) have declined to take part, all citing the new cost structure. It seems that some clubs don't automatically refund the competition secretary's ticket costs, so rolling tickets into the overall entry fee is a problem for them. We may need to reconsider this next season.

- 4. The next matter for consideration is transport of the boards, in the light of experience at the Exhibition.
- 5. I assume that, as last year, refreshments will be limited to tea/coffee and biscuits at the interval. We should think about who will manage this, if Nicky is helping with projection, and also where do we need to book the downstairs hall for a couple of hours?

## Internal Competition Secretary's Report November 2025, Louisa Christie Months 1 & 2

Month 1 & 2 competition has gone well.

I think culling if we get 65 to 70 plus images across both DPI & print is OK. It seems fairer for the second half as judges do take their time over prints.

November has seen a lower number of entries, so we haven't culled.

#### **Technical Issues FFPX**

FFPX hasn't been playing ball for a while. On the monthlies, I can no longer shuffle like I could before. The best I can currently do is distribute by Author.

There were problems with both mix & match and the recent knockout, where the software was not doing as it should.

I understand from Graham that we now have a direct contact email address to the guy who designed the programme, so perhaps if we gather the issues, we can email him to get some help.

No issues with this. I did have a big sort out with the categories as it was starting to look rather messy. This now looks much tidier & is easier to navigate.
